SB 2190 UPDATE

On August 30, 2022, the Texas First Court of Appeals issued a judgment and opinion overturning a district court order declaring SB 2190 unconstitutional and ruled in favor of the City's plea to the jurisdiction. The Fund is in the process of appealing the ruling to the Texas Supreme Court.

News from Member Services

COST OF LIVING ADJUSTMENT



The Fund's actuary determined that **COLA** is **4%** so members age 55+ and those receiving general disability benefits should have seen monthly amounts increase by 4% beginning with the **October 31, 2022** benefit payment.

DROP/PROP INTEREST



New Interest Rate is 6.1% effective September 1, 2022

Monthly Interest is calculated on account balance the last business day of each month and posts to the account by the middle of the following month.

ANNUAL SUPPLEMENTAL BENEFIT



The **ASB** will be distributed on or before January 16, 2023 to retirees and eligible survivors who were receiving service or disability retirement benefits as of June 30, 2022 and remain eligible on the distribution date.

ANNUAL EXCLUSION LETTERS



\$3,000 annual exclusion letters are for members (eligible survivors excluded) who pay toward COH medical, dental, or vision premiums. The letter should arrive by January 30, 2023. The amount will also appear on your December check stub in the year-to-date column.

Important Deadlines

DECEMBER 1, 2022 REQUIRED MINIMUM DISTRIBUTION (RMD) FORM OR FORCE



If you are 72 or older and have a DROP and/or PROP account, you are required by the IRS to withdraw a RMD or a 50% tax penalty could be assessed. The required amount is based on your age, spouse's age (if applicable), and your 12/31/2021 DROP/PROP account balance: RMD Calculator - note this calculator is not accurate if you are 10+ years older than your spouse. Remember, previous withdrawals in 2022 count toward RMD. If Member Services has not received your DROP or PROP Disbursement Form by December 1, 2022, HFRRF will force out your RMD at 10% tax withholding and deposit it to your account on file.

DECEMBER 16, 2022 DROP/PROP WITHDRAWAL DEADLINE



The last day to withdraw funds for 2022 from a DROP or PROP account is December 16, 2022.

State & Federal News



POST-ELECTION LEGISLATIVE UPDATE

Texas: When the Texas Legislature convenes on January 10, 2023, the State of Texas will have \$40 billion in surplus funds, the largest budget surplus in its history: \$26.95 billion in discretionary general revenue funds and \$13.66 billion in Economic Stabilization Fund (Rainy Day Fund) which can only be spent with approval of 2/3 supermajority of the Legislature.

The surplus is largely due to booming sales tax revenue which makes up more than half of the state's total revenue. Other surging tax receipts include taxes on natural gas production (up 184%), oil production (up 81%), and hotel occupancy (up 43%). The Governor, Lt. Governor and Speaker of the House have all stated they will use the surplus to cut property taxes next session. Lawmakers are also likely to address rising health care costs, increase funding for mental health and school security, and make the grid more reliable and resilient.

Following the election, the Texas Legislature remains relatively unchanged with Republican majority in House and Senate. The Big Three – Governor, Lieutenant Governor, and Speaker – all remain in their current roles.

Washington, DC: HFRRF has been in the forefront of efforts, for years, to repeal or reduce the impact of WEP and GPO. Windfall Elimination Provision (WEP) reduces Social Security benefits for individuals receiving a pension benefit from non-Social Security employment. Government Pension Offset (GPO) similarly affects spousal and survivor benefits.

HFRRF has been working closely with Rep. Kevin Brady (R-TX) and Sen. Ted Cruz (R-TX) to produce a WEP reform bill with a proportional benefit formula based on individual work history. HR 2337 by House Ways and Means Committee Chairman Richard Neal (D-MA) and HR 5834 by Rep. Brady offer similar approaches to replace the one-size-fits-all WEP penalty. Other active bills in Congress include HR 82 by Rep. Rodney Davis (R-IL) and S 1302 by Sen. Sherrod Brown (D-OH) to permanently repeal both laws. HR 2100 by Rep. John Larson (D-CT) would repeal WEP and GPO for five years. The current session will end in December, most likely without passage of any WEP legislation.

The 118th Congress will convene in January, but the political makeup remains uncertain. Early election results are not definitive. The Senate majority may be decided in one or more run-off elections in December. The House majority is not official either, but Republicans secured enough seats to secure a majority. Rep. Kevin Brady, friend and ally of HFRRF for 20 years, will not be returning to Congress. He has been our local champion for repeal of WEP and GPO and will be missed. We thank Congressman Kevin Brady for his years of support and wish him well in retirement.

HFRRF will continue to educate new legislators and work with key Representatives and Senators to advocate for our members on every issue related to the pension.
