TRUSTEE ELECTION

The HFRRF Board of Trustees consists of five active firefighters, one retired firefighter, two citizen members, city treasurer, and mayor or their appointed representative. Elections are held annually for expiring firefighter positions. Please make sure you are enrolled in MemberDirect to receive communications. If you need help enrolling, or have questions about the election process, please call 281-372-5100.

NOMINATIONS - August 1st through August 18th at 4pm

Members may nominate other members or themselves. The nomination form is available online at www.hfrrf.org and at the pension office. Completed nomination forms will be accepted at HFRRF during business hours, in the Member Drop Box on the covered porch after hours, and by email to HFRRFelections@hfrrf.org.

NOMINEES

Members will be notified of their nomination. To be included as a candidate on the ballot, nominees must submit Accept/Decline Nomination (unless self-nominated). Nominees may also submit a one-page election profile to be distributed with ballots. All forms must be received by HFRRF no later than August 25th at 4pm.

VOTING - October 2nd through October 19th

Voting is conducted by secret ballot through an independent auditor/election service. Ballots are individually numbered and paper ballots cannot be reproduced. The service sends ballots, candidate profiles, and voting instructions to all eligible members via email and USPS first class mail. Votes may be cast electronically or by a mailed paper ballot. Ballots containing a write-in candidate and all ballots received after the October 19th deadline will be invalid.

RUN-OFF

A run-off election will be held if a candidate does not receive a majority of votes cast. The two candidates receiving the largest number of votes will be eligible for the run-off and must submit a new Accept/Decline Nomination Form to the Fund by October 27th. Ballots will be mailed/emailed to eligible voters. Run-off ballots must be received by the service November 3rd – 24th.

RESULTS

The independent auditor/election service certifies election results to the HFRRF Board of Trustees. Election results will be announced on **October 20**th and run-off results on November 27th. HFRRF will post the election results on www.hfrrf.org.

To Log into MemberDirect:

- 1. Enter your username and password
- 2. Answer the challenge question
- 3. A text message with a code will be sent to the cell phone number on file
- 4. Enter the 4-digit code
- 5. Select "trust this device" so no code will be required on that device for 3 months
- 6. Click continue to access your account
- *From now on, when you log in, you will not need to answer security questions.*

In the future, when you need to update contact information, log into MemberDirect, click "Personal Information" on left side, update cell number, address, etc., then click "update" to save.

Depression After Retirement

Jack was looking forward to retirement and expected to live a long and healthy life. He ate right, exercised and made sure he had his regular checkup with his doctor. However, Jack

had a setback with his health and although he recovered, he noticed that he was feeling in a funk. He just couldn't shake these blah feelings. He no longer wanted to play golf, which was an activity he once enjoyed with his friends. He also wasn't sleeping well and he often felt guilty because he was more irritable towards his spouse. Jack thought this must be a normal sign of aging so he continued to ignore it and things just seemed to get worse.



Life as an older person brings unique challenges and struggles. Life doesn't always go as planned. The difficulties of an uncertain future or changes in health may bring sadness as we grow older. That sadness may continue to worsen until it becomes depression.

Let's look at a few of the causes of depression after retirement:

- 1. Loss of loved ones Suffering through the death of a loved one is a bit different as we get older. Losing friends your own age, and possibly your spouse, will tend to remind us of our own mortality. Not only will we suffer the loss but will also experience loneliness at the same time.
- 2. Loss of independence Loss of independence as we age is rated the number one reason for frustration and depression. Not being able to care for oneself means that someone else has to do it for you. Family members may be willing and able to care for you but giving up our independence and control of our own life is territory we are not used to. Think about it. A person who once rescued others, ran a business, raised a family, flew combat missions, performed surgeries, or built a town is going to suffer a great deal if their independence is taken away from them as they age.
- 3. Illness When we get older, recovering from an illness or injury takes more time, with the outcome oftentimes discouraging. A simple accident like a fall can fracture a hip, back, or pelvis which can result in a loss of more independence or even needing long-term care. Being in pain constantly and facing debilitation can lead to a great deal of sadness and frustration. These feelings may in time worsen and grow into a full-blown depression.

Even with these obvious causes of depression, many people are hesitant to discuss their symptoms with their doctor, especially if some of the symptoms are subtle or don't seem to "be a big deal." This leads to undiagnosed depression and needless suffering. If you have experienced additional life transitions or some of the symptoms listed above, discuss solutions with your doctor. Online DROP/PROP Withdrawals

Did you know that you can make DROP/PROP withdrawals online? Log into MemberDirect and go to My Account. Choose Forms. For a lump sum withdrawal up to \$50k, use the Disbursement Form. If you want to set up recurring monthly or quarterly withdrawals, submit the Periodic Disbursement Form.

Member Services Reminders

- If you recently got married, make sure you submit a marriage license along with your spouse's social security number and date of birth to the pension office, so we can add it to your record.
- COLA (Cost of Living Adjustment) can range from 0-4%. COLAs will appear on your October 31, 2023 pension check.
- We are halfway through 2023. RMDs (Required Minimum Distributions) must be taken from your DROP/PROP by 12/1/2023. You may choose 0-99% taxes on your RMD portion.
- Keep your contact information updated to help ensure we can connect with you about important information regarding your benefit or account.
