

#### TRUSTEE ELECTION

Houston Firefighters' Relief and Retirement Fund, created by state statute, gives the Board of Trustees the responsibility to serve as Plan Administrator. The ten-member board consists of five active firefighters, one retired firefighter, two citizen members, the city treasurer & the mayor or their appointed representative. Elections are held annually for expiring firefighter positions.

The following is a summary of the upcoming election. This year, the election process will include electronic communications. If you are not currently enrolled in MemberDirect, see page 5 for more information.

Firefighter Trustee Positions up for Election

Position	Term Begins	Eligibility Requirements
I	January 2022	Engineer/Operator or Firefighter
X	January 2022	Retired Firefighter with at least 20 years participation in the Fund

#### **Nominations**

By July 1, members are notified of the upcoming election by HFRRF Summer Red Line Newsletter, HFRRF website (www.hfrrf.org) & HFD email system. To make a nomination, members submit a form that states who is being nominated & by whom. Members can submit their own nomination. The nomination form is available for download on www.hfrrf.org or may be picked up at HFRRF. Nomination forms will be accepted by HFRRF August 1 – 20 during regular business hours at 4225 Interwood N Pkwy, Houston 77032. After hours, forms may be placed in the Member Drop Box located on the covered porch or submitted by email to HFRRFelections@hfrrf.org. Deadline for nominations is August 20 at 4pm.

#### **Nominees**

Members are notified of their nomination. To be included as a candidate on the ballot, nominees must submit Accept/Decline Nomination & Financial Disclosure Forms. Members who nominate themselves are automatically placed on the ballot unless their Financial Disclosure Form is not received. Nominees may submit a one-page election profile to be distributed with ballots. Required forms must be received by HFRRF no later than 4pm on August 27.

#### **Voting**

Voting is conducted by secret ballot through an independent auditor/election service. Each ballot is individually numbered & paper ballots cannot be reproduced. The service sends ballots, candidate profiles & voting instructions to all eligible members via email & USPS first class mail. Votes may be cast electronically or by a mailed paper ballot. Ballots containing a write-in candidate will not be counted. All ballots must be received by the independent auditor/election service October 1 - 20.

#### Run-Off

Should a candidate for election fail to secure a majority of votes cast, a run-off election is held. The two candidates receiving the largest number of votes are eligible for the run-off & must submit a new Accept/ Decline Nomination Form to the Fund by October 27. Ballots will be mailed/emailed to eligible voters. Run-off ballots must be received by the service November 3 – 22.

#### Results

The independent auditor/election service certifies election results for trustee positions to the HFRRF Board of Trustees. Election results will be announced on October 21 & run-off results on November 23. HFRRF posts election results on <a href="https://www.hfrrf.org">www.hfrrf.org</a>.

Mark your calendar & be sure to vote!

#### TRUSTEE ELECTION SCHEDULE

The election process begins in July for trustee positions that will expire on or before January 1st of the following year.

Regular voting ends & winners are announced in late-October. If a run-off election is required, the process may last another month. (Special elections may be conducted at any time for vacant positions.)

### **ASK MEMBER SERVICES**

Q: WHY DO I OWE TAXES EVEN THOUGH 20% TAXES WERE WITHHELD?

**A:** If you receive DROP/PROP account proceeds, the distribution is considered income in the year you receive it. The minimum federal income tax rate that must be withheld is 20%, but your tax bracket may be higher. If you receive payment & are not 50+ in the calendar year that you leave active service, or if you withdraw money from a rollover account before age 59½, you may be subject to 10% early distribution tax penalty. We urge you to seek the advice of a tax professional.

**Q:** HFRRF TOOK OUT MY RMD SO I WOULD AVOID THE 50% PENALTY. WHY WAS 10% WITHHELD FOR TAXES INSTEAD OF 20%?

**A:** You may elect to withhold 0 - 99% for taxes on RMD. If no election is made, HFRRF automatically withholds 10%.

**Q:** IS THERE A MINIMUM AGE TO RETIRE?

**A:** No, but to be eligible for service retirement, you must have 20+ years of service if you were hired as a firefighter before July 1, 2017. Your age plus years in the Fund must equal 70+ if you were hired as a firefighter on or after July 1, 2017. If you were hired as a firefighter prior to July 1, 2017 & leave HFD with 10 - 19 years in the Fund, you may choose to receive a deferred benefit to begin at age 50.

Q: WHEN WILL I SEE MY CHECK STUB IN MY MEMBERDIRECT ACCOUNT?

**A:** Payment history is uploaded on the 2nd business day of every month.

Q: WHEN ARE PENSION CHECKS DEPOSITED?

**A:** Direct Deposit monthly pension payments are scheduled by our custodial bank on the last day of the month. The day it posts to your account is controlled by your financial institution.

**O:** HOW MANY DIRECT DEPOSIT ACCOUNTS CAN I HAVE ON FILE?

**A:** (1) primary & (1) secondary direct deposit account

Q: WHEN WILL I RECEIVE MY FIRST PENSION PAYMENT AFTER I RETIRE?

**A:** Once we receive your routing slip & all contribution payments from the City, we will process your retirement & issue a check. In most cases, you will receive payment by the end of the month.

**Q:** WHEN WILL I RECEIVE MY \$5K ADDITIONAL RETIREMENT BENEFIT AFTER I RETIRE? *A: Approximately 5 - 7 business days after the date off payroll.* 

**Q:** IF I AM ON GENERAL DISABILITY, WHAT IF I DID NOT TURN IN MY DISABILITY PAPERWORK BY THE JUNE DEADLINE?

A: Submit the paperwork asap - you will not receive payments until we receive it.

Q: WHAT IS MemberDirect & HOW DO I SET UP MY MemberDirect?

A: <u>To learn more about MemberDirect</u>, watch the video on <u>www.hfrrf.org</u> (bottom of the page.)

<u>To set up an account</u>, go to <u>www.hfrrf.org</u> & click in the upper right corner, then **Enroll**. Now, click the words **Request an Enrollment PIN**. A PIN will be mailed to you.

When you have the PIN, go to the website again & click <u>Login</u>, then <u>Enroll</u>. Now, type the PIN you received in the mail & finish setting up your account. Be sure to <u>save your username & password!</u> Call Member Services if you need assistance.

#### NEW LIGHT ON THE SUNSHINE VITAMIN

It used to be simple: just get a "healthy" tan & your body will make all the vitamin D it needs. Desk jobs & sunscreen changed that, just as research is underlining the importance of vitamin D & its possible role in preventing many health problems.

Vitamin D is a crucial component of healthy aging. It helps you absorb calcium for strong bones. Your body also needs vitamin D to move your muscles & for nerves to carry messages from your brain. Plus, your immune system needs it to fight off invading bacteria & viruses.

Many older adults don't get enough vitamin D & experience symptoms of deficiency including:

- Weak muscles which can increase the risk of falls
- Changes in mood & cognitive function low vitamin D has been linked to depression
- Weight gain lack of vitamin D can block the function of leptin, a hormone that inhibits hunger & reduces fat storage
- Softening of bones which makes them more likely to break
- Digestive issues inflammatory bowel disease/irritable bowel syndrome

Natural sources of vitamin D for Recommended Dietary Allowance (RDA):

- Sunshine one of the best natural sources of vitamin D your body produces enough vitamin D from 10 30 minutes of midday sun
- Cod liver oil 1 tablespoon has 170% limit use to avoid high levels of vitamin A
- 4 5 slices of white mushrooms provide 50%
- 5 oz cooked salmon accounts for more than 80%
- 1 cup of fortified milk contains 20%

Beyond the natural sources, your doctor or dietitian may also recommend a supplement to ensure you get enough vitamin D for healthy aging.



#### PROTECT YOURSELF



2021 HURRICANE SEASON June 1<sup>st</sup> - November 30<sup>th</sup>

NOAA's Climate Prediction Center expects another busy season, but hopefully not the historic levels seen in 2020. Scientists have forecasted 13 - 20 named storms including 6 - 10 hurricanes of which 3- 5 could become major hurricanes.

**PREPARE** If you haven't already, it's time to create/ update your disaster plan & gather essential supplies. In addition to the usual important documents, food, water, medicine, radio, flashlight, batteries & pet supplies, add face masks, hand sanitizer & disinfecting wipes to your emergency kit.

**REGISTER** for AlertHouston, the city's emergency alert system. You will receive real-time weather alerts as well as storm recovery information.

**GAS UP** the car & map out evacuation routes. Where will you go? Take time to locate a shelter near you before you need it. Text SHELTER & your zipcode to 43362 for locations (Example SHELTER 77032). Houston's OEM website houstonemergency.org has links to Red Cross for shelter locations, FEMA disaster assistance & STEAR where you can register for help in the event of a disaster.

**REVIEW** the disaster plan with everyone in your home. Also, make sure they all know the safest place to be in your house during a storm.

**STAY SAFE** after a hurricane. Wash your hands when possible & use hand sanitizer when soap & water aren't available. For recovery information, go to the website www.houstonrecovers.org. Keep yourself & your family safe this hurricane season!
